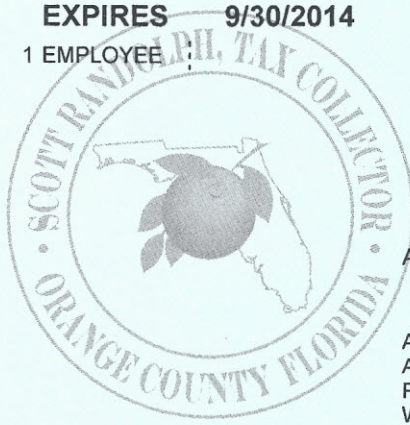


Scott Randolph, Tax Collector Local Business Tax Receipt Orange County, Florida
